ORDER

Since a Corona positive case has been reported in **Old Char Chaman, Nagpal Wali Gali, Karnal**. As per the location of the house of the individual, **Sh. Nizamudin Khan S/o Sh. Amantulya Khan, the street from Shop of Punjab Sales to Shop of A.P.S. Collection and from Shop R.S. Communication to Hotel Kanal Inn is declared as containment zone. Further, the entire geographical area of Old Char Chaman of ward No. 11, Karnal is declared as Buffer Zone** for all the purposes and objective as prescribed in the protocol of nCOVID-19 to prevent its spread in the adjoining areas.

For combating the situation at hand, the following action plan is prescribed to carry out screening of the suspects, testing of all suspected cases, quarantine, isolation, social distancing and other public health measures in the Containment Zone as well as Buffer Zone effectively:

- 1- Sufficient number of Teams for conducting door to door screening/thermal scanning of each and every person of the entire households falling in the Containment Zone shall be deployed by the Civil Surgeon, Karnal. All of them would work under the strict directions of the Civil Surgeon, Karnal. All the staff on duty shall be provided with personal protective equipments and other required devices for screening/thermal scanning etc. Gates/Door Knobs of each and every household will be properly sanitized.

(Action by: Civil Surgeon, Karnal)

- 2- The entire areas of Containment Zone and Buffer Zone will be fully sanitized by the Deputy Municipal Commissioner, Municipal Corporation, Karnal. It shall be ensured by him that the staff deployed for complete sanitization of the locality is adequately provided with personal protective equipments viz. face masks, gloves, caps, sanitizers, shoes and also follow social distancing norms.

(Action by: DMC, Municipal Corporation Karnal)

- 3- Movement of public of the inhabitants of Containment Zone shall be absolutely restricted and the entire Containment Zone shall be sealed by deployment of adequate police force and setting up of required number of Nakas etc.

(Action by: SP, Karnal.)

- 4- Necessary barricading of the Containment as well as Buffer Zone shall be done by the Executive Engineer, PWD (B&R) Divn.I, Karnal in consultation with Superintendent of Police, Karnal.

(Action by: XEN, PWD (B&R) Divn. I. & SP Karnal)

- 5- Sufficient stock of personal protective equipments/devices and required medicines shall be kept at the control room by the Civil Surgeon, Karnal.

(Action by: Civil Surgeon, Karnal)

- 6- Kalpana Chawla Govt. Medical College, Karnal is declared as Containment/Isolation/COVID Hospital. Director KCGMC and Civil Surgeon, Karnal shall ensure that all required health-care/medical facilities are in place to meet any emergency.

(Action by: Director KCGMC and Civil Surgeon, Karnal)

- 7- General Manager, Haryana Roadways, Karnal shall deploy two buses exclusively for carrying the health teams constituted for door to door screening/thermal scanning from Hospital to the Zones and drop them back.

(Action by: General Manager, Haryana Roadways, Karnal)

- 8- Demand of essential goods/commodities such as raw ration/milk/grocery/medicine/ vegetables shall be worked out and lists shall be prepared by the **Joint Commissioner, Municipal Corporation, Karnal** in coordination with **MD, Sugar Mill, Karnal**. There shall be separate packets of vegetables, ration/grocery items; milk etc. and delivery of the same would be ensured at the door step. The delivery personnel would wear personal protective equipments and drop the packets at the door itself. He will not go inside of any house or make physical contact with any person. Accountability of the essential goods/items received and distributed to the households shall be maintained by the above officers on daily basis for which they may deploy adequate staff from their own office.

(Action by: Joint Commissioner, MCK and MD, Sugar Mill, Karnal)

- 9- Regular power supply in the Containment/Buffer Zone shall be ensured by SE, UHBVN, Karnal.

(Action by: SE, UHBVN, Karnal)

- 10- Regular safe drinking water supply shall be ensured by the SE Public Health, Karnal.

(Action by: SE Public Health, Karnal)

- 11- Ambulances and other Para-medical staff shall be deployed by the Civil Surgeon, Karnal.

(Action by: Civil Surgeon, Karnal)

The **Sub Divisional Magistrate, Karnal** shall be the overall In-charge of the Containment/Buffer Zone and to over-see all the arrangements.

All the officers/officials on duty shall perform/discharge their duties efficiently and any laxity on the part of any officer/official will attract strict action under the provisions of Disaster Management Act, 2005.
